Contest Rules and Regulations

1. Contestants must have reached the age of 21 at the time of contest and be able to show proof of age.
2. Any Contestant, dresser, back-up dancer, etc. caught in the act of stealing or tampering with another contestant's property will automatically be disqualified and entry fee will not be returned.
3. Presentation should fit the theme of the evening and will be judged and not scored but awarded a monetary gift.
4. Talent shall be no more than 5-minutes with a 2-minute window on each side for prop set-up and take down.
5. Any prop that is dangerous to another contestant or audience member is prohibited. Any use of a dangerous prop will result in a ZERO score for the contestant.
6. Contestants must complete all categories listed below. Maximum point value for each category is listed in parentheses.

Presentation	(Not Scored)
Talent	(85 points)
Formal Wear	(40 points)
On Stage Question	(25 points)

Talent: The same applies as Miss Icon. (See #4 above)

Formal Wear: This category is a Tuxedo, open to any color of tux. You may also add color to your tie or vest, or bowtie and cummerbund. NO added rhinestones or glitter is allowed to adorn the tuxedo. This is not USA formal wear, this Mr. Club formal wear.

On Stage Question: This category will take place right after formal wear. Your question will come from the judge's panel. You are asked one question and this will give you a chance to speak publicly and by only having on stage question, this is your interview so you must answer the questions to the fullest of your ability.

7. Pageant staff reserves the right to make decisions on any matter not explicitly covered in the rules and regulations.
8. Pageant winner will be required to appear and perform in the following bookings:
 - Club ICON Holiday Christmas Show (Paid Booking)
 - Club ICON Annual Anniversary Show (Paid Booking)
 - Mr. Club ICON Show (Paid Booking—theme, creation, and organization of this show will be at the discretion of the pageant winner with approval from pageant staff and Club ICON Management.)
 - Mr. Club ICON pageant (\$50 for completing full reign as described in rule 10 below)
 - Club ICON Annual TurnAbout fundraising event (UNPAID Booking)

- Club ICON at Pridefest Milwaukee and annual Parade Float (UNPAID Booking)

In each Paid Booking listed above the pageant winner will represent Club ICON and will be required appear as Mr. Club ICON wearing the Club ICON sash.

9. The winner of Mr. Club ICON will be required to compete in the Mr. Wisconsin Club Competition as Mr. Club ICON (regardless of any other title that Mr. Club ICON may hold that would also qualify for participation in that competition). Not open for discussion or rule change.
10. The winner will receive \$100.00 at the time of sashing. An additional \$50 will be received by the winner at the end of their reign under the condition that they have successfully and satisfactorily completed their full reign and fulfilled each obligation of their reign as Mr. Club ICON.
11. First Runner up will receive \$50.00 cash prize.
12. Contestants must be registered by 8:00 p.m. the day of the contest. A contestants meeting will be held promptly at 8:00 p.m. Any contestant that is not registered by the start of the contestants meeting will not be allowed to compete and will and registration fee will not be refunded. During the contestants meeting, contestants will participate in the process that determines contestant order and receive information on contest agenda.
13. Registration Fee for contest is \$35.00.
14. Music and instructions must be delivered to pageant staff at the time of registration. All music must be in CD format. The first track of the CD will be designated for talent (if using music). The second track will be designated for sashing presentation.
15. All above Rules and Regulations are set by the owner of the pageant. The pageant owner reserves all rights to dismiss contest winner if found of any misrepresentation of the Mr. Club ICON title; this includes, but is not limited to, any theft; use or illegal disbursement of drugs or any illegal substances; legal litigations; or any conduct that is unfashionable, disrespectful, or in any way compromises the integrity of the Mr. Club ICON title, pageant staff, or the staff, management and entity of Club ICON and ICON Enterprises, L.L.C.
16. In addition to obligations listed above, contest winner is encouraged to periodically represent and adorn the Mr. Club ICON title and sash and will receive employee prices and free cover when doing so at Club ICON.
